This ensures the program remains as transparent and flexible as possible, while aligning with the nature of the mining activity itself.

# How it works

## Subscription to the program

## Distribution of earnings

## Extension of a proof of work blockchain (e.g., bitcoin blockchain)



Payment or Transfer in BTC



Transaction Request (send)



The transaction is grouped into a "Block"



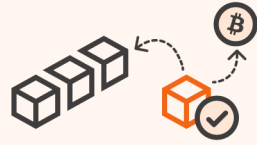
The block is broadcast to the Bitcoin network



Receipt of payment or transfer in BTC (transaction validated)



Once the validation process is complete, the block is added to the Bitcoin blockchain immutably



The data center receives a portion of Bitcoin as a reward in exchange for its computing power



The network validates the transactions included in the block using the computing power provided to the network by a data center

Our sophisticated IT infrastructure contributes to the expansion of the decentralized network of proof-of-work blockchains

# Blocked capital and early exit option

## How Exit Windows Work:

The windows of exit are specific periods that offer an opportunity for liquidity for those wishing to transfer their cloud mining contracts. They allow investors to transfer their contracts and enable others to acquire them. Here's how they work:

### For Sellers

The exit windows allow investors to transfer their contracts after a minimum lock-in period of 6 months, despite an initial commitment period of at least 48 months. This gives sellers the option to actively manage their portfolios and control their exit process.

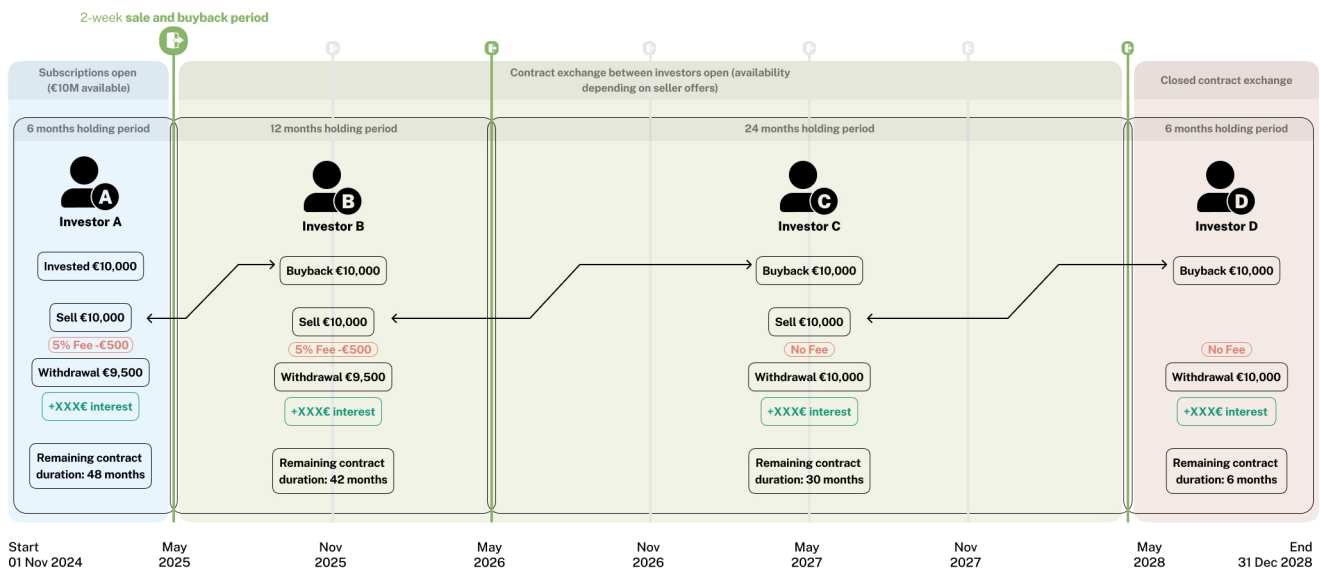
### For Buyers

These windows offer new investment and diversification opportunities. Buyers can access existing contracts with a reduced lock-in period, making it easier to enter the cloud mining space.

### Opening Period

The exit windows are open for 2 weeks each year, once in May and once in November.
